Moments Later, Spo Carozza Advised Via Dispatch That The Suspect, A Dark Skinned Black Male Wearing Black Cargo Pants, A White T-shirt And A Black Jacket Had Taken Off Running Towards The Westin Hotel At 3391 Peachtree Rd And He Was Armed With A Handgun. I Responded To The Area Along With Several Other Units And Phoenix And Were Unable To Locate The Suspect At The Time. After Our Search Of The Surrounding Area Came Up Inconclusive, I Met With Mr. Marco Ramirez (404.696.0448 2832 Skyland Way # A Atlanta Ga 30319 11.29.68). Mr. Ramirez Advised That At Approximately 3:50 Pm On Today's Date, He Was Entering 3393 Peachtree Rd To Go To Work At The California Pizza Kitchen. Mr. Ramirez Advised That While Walking Towards The Escalator He Noticed The Suspect In What Appeared To Be A Sheriff's Uniform. Mr. Ramirez Advised That The Suspect Approached Him And Demanded A Georgia Identification Card From Him. Mr. Ramirez Advised That He Told The Male That He Did Not Have A Ga Id And The Male Told Him That He Was With The Fulton County Sheriff's Office And That Mr. Ramirez Needed To Pay Him \$500 In Cash For An Outstanding Warrant Or He Would Be Deported. Mr. Ramirez Advised That He Was Nervous About The Situation And He And The Suspect Went Into The California Pizza Kitchen And Spoke With His Supervisors (Tutu Tigneh And Leangelo Emperor 404.262.9221). Mr. Ramirez Advised That The Subject, Who Identified Himself At That Time As Fulton County Deputy Sheriff Charles Timmons (badge # 61443) And That He Needed \$500 In Cash Or Mr. Ramirez Would Be Detained And Eventually Deported. Mr. Ramirez Advised That He, Accompanied By C Timmons Went To The Atm And He Withdrew The \$500 In Cash. Mr. Ramirez Advised That He And C Timmons Returned To His Manager's Office Where C Timmons Again Demanded The Money. Mr. Ramirez Advised He Took The Money Out Of His Pocket And C Timmons Snatched The Cash From His Hand And He Then Left The Location. Mr. Ramirez Advised He Requested To Go Home Early Today Because He Was Very Nervous.

Mr. Ramirez Advised That When He Was Waiting At The Marta Station At 855 E Paces Ferry Rd, He Saw C Timmons Again. Mr. Ramirez Advised That C Timmons Apologized To Him And Stated That He Had A Job To Do And He Had Two Kids At Home And A Girlfriend. Mr. Ramirez Advised That C Timmons Then Walked Away From Him And Returned A Few Minutes Later Holding Onto Mr. Lazaro Ramirez's Shirt. Mr. Ramirez Advised That C Timmons Requested That He Translate For Mr. L Ramirez Because He Could Not Speak English. Mr. Ramirez Advised That C Timmons Requested That He Ask Mr. L Ramirez For His Ga License And Mr. L Ramirez Advised He Did Not Have A Ga Id.
