The Employee Further Reports The Furniture Within The Congregation Room Was Turned Over And Graffiti Written On The Walls And Countertops. There Was A Strong Odor Of Marijuana Present At The Time Of The Call. It Is Believed That Two Teenagers Were Responsible For The Damage Although No Video Was Present To Support The Theory.
