Report Summary

On Wednesday January 11th, 2012 Mr. S entered the City of Atlanta Police Department Zone Three Precinct and advised that he needed to file a police report in regards to larceny from vehicle. According to Mr. S he parked his 2007 Chevrolet Silverado pick-up truck in the parking lot of 1xxx Moores Mill Rd NW, the YMCA at approximately 2:00p.m. to work out. Before entering the facility Mr. S made sure all the windows and doors to his pick-up truck was locked and secured. After he completed his work out Mr. S returned to his pick-up truck and drove to his place of residence. Upon exiting his pick-up truck to enter his residence Mr. S went to reach for his Dell laptop computer, which was resting on the back seat, and noticed that it was no longer there. Mr. S immediately began searching the interior of his pick-up truck but was unsuccessful in locating his laptop. Mr. S stated that his laptop, which was housed in a black carrying case, was resting on the back seat when he exited his vehicle and entered the YMCA. He immediately notified the 911 however when he explained to the 911 operator that his laptop was stolen in the City of Atlanta, he or she explained to him that he had to return to the scene or go to a police precinct nearby in order to file a police report. Mr. S also stated that there were several documents that pertains his personal information housed inside the carrying case. It is unclear at this time how the perpetrator(s) broke into his vehicle to take possession of the laptop. I notified Zone Two CID (Criminal, Investigation, Division) and unit acknowledge the call via phone. A copy of this incident report was faxed to Zone Two CID for further investigation.

Caller advised she was outside changing her light bulb on the front porch. She looked over and saw a black male walking away from a dark vehicle parked on the street towards the rear of the house. Units arrived on scene approximately 6-7 minutes later and discovered a Green Nissan Altima Alabama tag, parked in front of the location still running and the rear door kicked open. Units secured the home and canvassed the area. Lt J discovered a bench tipped over as if someone tripped over it in the back yard and a pair of jeans on the fence in the back yard which eventually lead to Moores Mill Rd. Units were unable to locate any suspects in the area. I arrived on scene and spoke with the caller. She advised the suspect was still inside the location when police arrived. She advised she saw lights going off as police cars pulled up. The caller advised she could not see a face on the suspect she just advised it was a black male walking through the front yard by the woodline. I contacted Det Y and advised him to run the tag and get owner information and see if he could contact them and see who was driving the vehicle. Det advised he was already on it and would contact me with info. Det advised he spoke with the owner of the vehicle and they advised a Derrek M was the only person driving the vehicle. Det advised the last known address was 2xxx County Line Rd(Z4) I contact Z4 and spoke with Sgt C and advised him of the situation and asked if he could send a car by the location to get info. Sgt C had a unit respond to the location but the home owner advised Derrek lived there briefly a few years ago but had not heard from him since.

The victim was not home but was notified by neighbors and arrived on scene about 30-40 minutes later. While I was talking with the victim he got a phone call from a neighbor who was aware of the situation advising she saw a black male with a red hoodie walking Southbound on Interstate 75 from Moores Mill towards Howell Mill. I gave the look out over the radio at approximately 2220 hrs. Radio advised there was no units in service. I left the burglary scene and headed down Moores Mill towards I75. I got on 75 South and towards Howell Mill. As I got to the exit ramp on Howell Mill I witnessed a black male with a red hoodie walking up the exit ramp.(Walking on Controlled access Highway) I advised radio and waited for the subject to get into a parking lot so I could talk with him off the street. I pulled into the Shell station ahead of the subject and waited for him. The subject walked into the Shell parking lot and I approached him. I asked him where he was coming from and he advised " I have been walking down 75 south for awhile. My friends car ran out of gas and he left me. " I asked his name and he gave Tramain J 10-4 93. Officer F arrived on scene shortly after I pulled out on radio. I ran him on acic and it came back 28b with a description of 510 and 180lbs. The subject I was talking to was about 505 125lbs. I asked him more info about where he was coming from and he advised he was riding around with a guy name "Big D" and there red vehicle ran out of gas. He advised Big D called a girl to come and pick him up. He stated Big D told him to wait with the car while he went with the girl to get gas. "Tramain" advised he waited for a while and decide to start walking. I advised the subject he was being detained for further investigation due to his stories not adding up. Officer F asked "Tramain" if he had anything in his pocket and Tramaine advised a phone, which earlier he said he did not have one. Officer F asked for permission to reach into his pocket to retrieve the phone and "Tramain advised Yes. Officer F pulled out a Motorola slide phone which the subject advised he found on the road. I took the phone back to the victim and he advised it looked like his old phone. He plugged the phone in to the charger on his end table. After the phone booted up the screen saver was a picture of his daughter. The victim confirmed the phone that was recovered on the subject I stopped was his phone which was taken from his home. Upon further search incident to arrest on "Tramain" 2 other ipods were located on his person which belonged to the victim. The subject was transported back to the Zone 2 Precinct for further processing and questioning.

Detective Y and myself interviewed "Tramaine" which changed his mind and gave us a name of Sanchez M 5-17-1994. M was given a Miranda form which he signed and agreed to talk. When asked about the stolen phone and ipods on his person he advised he found them on the road as he was walking. After further questioning and presentation of evidence against him M continued to change his story. Det Y questioned M further after M initiated further conversation about the incident. M advised once again he was going to tell the "truth". M advised he was riding around with "Big D" which turned out to be Derrek M (confirmed by photo shown to M) and Issiah S. He advised M was driving the Green Nissan (found on scene) with Issiah S in the front passenger seat. M advised he was in the back seat asleep. M advised he woke up to M stopping at a few different houses looking to burglarize. M advised M stopped in front of the location that was broken into (2xxx Ridgemoor Rd) and M and S got out of the car and went up to the house and knocked on the door. M advised M and S went to the rear of the house and then he saw them inside the house. M advised he exited the vehicle and waited in the neighbors yard while the two were inside the house. M advised M and S brought out a Playstaion 3, cell phone, Ipods, Red Nintendo DS and gave them to him to put in the waiting car. M advised he did not want nothing to do with what they were doing so he dropped the PS3 but kept the phones and ipod. M advised he then saw a police car arriving so he took off. M advised he did not know where or what happened to M and S.

To confirm M was truthful in his testimony I Presented a picture of Issiah S along with three other similar subjects and had him point out which one was Issiah S. M pointed out the photo I had gotten off of Police central of Isiah S. All property recovered on M was returned to the victim. M wrote out a statement what each persons involvement was in the burglary and the entire interview was recorded.

Additional warrants will be taken out on M and S.
